Nothing in this Delegation shall preclude the Under Secretary/Administrator from exercising any of the authority so delegated.

EFFECT ON OTHER DELEGATIONS:

This Delegation combines into one document several documents delegating authority to the NOAA General Counsel over the last twenty (20) years, streamlines while maintaining those delegations, and updates the authority delegated to reflect recent amendments to Department Organizational Order 10-15.

All prior delegations by the Under Secretary/Administrator to the NOAA General Counsel are superseded including: Delegation by the Under Secretary/Administrator to the NOAA General Counsel dated March 3, 1992, at Transmittal # 29 in the NOAA Organizational Handbook, and amendments thereto at Transmittal # 62 (Aug. 30, 2006) and Transmittal # 72 (Jan. 18, 2008).
