OMAO Delegations of Authority

The Director of the National Oceanic and Atmospheric Administration Commissioned Officer Corps (NOAA Corps) and Director of the Office of Marine and Aviation Operations is delegated the authority to act with respect to those matters listed in sections 3.01d, j, k, 1, and m of Department Organizational Order (DOO) 10-15 as they relate to the commissioned officers of the National Oceanic and Atmospheric Administration. Please note the Secretary has reserved to herself the authority to appoint and promote commissioned officers.

Pursuant to Department Administrative Order (DAO) 202-250, section 5.04, the Director of the NOAA Corps, the Deputy Director of the NOAA Corps, the Director of the Commissioned Personnel Center, and all officers in a command billet are delegated the authority to administer the oath incident to entrance on duty in the commissioned corps.

The Director of the Office of Marine and Aviation Operations and the Deputy Director for Operations, OMAO, is delegated the authority to provide NOAA policy and procedures for the payment of commuted subsistence allowances for NOAA vessel employees.
