




Chart 3 provides an overview of the task order awards accomplished to date by socio-economic status.





Chart 4 is an overview of the set-aside determination for task orders currently under solicitation or evaluation.

Chart 5 provides an overview of the Fisheries Domain task order awards accomplished for this quarter by socio-economic status.




Chart 5.5 provides an overview of the Fisheries Domain task order awards accomplished year to date by socio-economic status.





Chart 6.5 provides an overview of the Oceans Domain task order awards accomplished year to date by socio-economic status.






Chart 3 provides an overview of the task order awards accomplished to date by socio-economic status.





Chart 4 is an overview of the set-aside determination for task orders currently under solicitation or evaluation.

Chart 7 provides an overview of the Satellite Domain task order awards accomplished for this quarter by socio-economic status.





Chart 7.5 provides an overview of the Satellite Domain task order awards accomplished year to date by socio-economic status.
