NOAA's Transition to BAS



NOAA's Official Transition to BAS: 10/1/2023



With the transition to BAS, the DOC will also use the <u>Invoice</u>

<u>Processing Platform</u> (IPP) to process contractor payment requests,

<u>DocuSign</u> to execute Awards, and <u>Fedconnect</u> to distribute Executed Actions and Post Solicitations.

No change in Forecasting, still posted to DOC website.

IPP is available at no cost to commercial vendors and independent contractors doing business with NOAA. Vendors are required to register for IPP or obtain a valid exception.

Contact your Contracting Officer if you have any questions regarding payment of invoices submitted during the black out (10/1-10/25) or are at risk for a hardship due to lack of payment.



- View payment history and download remittance data online
- Choose simple email notification of payment or detailed remittance information
- More easily manage their receivables with associated payments

IPP Training & Assistance



- Vendor training materials, including a first-time login tutorial, are available on the website.
 - Users can access guides with step-by-step instructions for all IPP capabilities, including creating and submitting invoices and setting up email notifications.
 - Monthly live webinars provide a great opportunity to learn system basics and ask the IPP team questions about the application.

- Distribution for Modifications and Award changed
 - DocuSign -Signature & Execution
 - FedConnect- Distribution/Notification/Opportunities

 Documents may look different due to the new system, such as formatting and fonts.



DocuSign























- Vendors will receive DocuSign notifications via an email from DocuSign and currently the CO's name will show as "Randy Platter".
- Easy follow instructions are provided to sign the documents.
- Vendors will then receive the executed documents as PDFs once the Gov't fully executes the document.
- By opening the DocuSign email, the details of the Award or Modification are clearly visible so that Vendors are aware what they are being asked to sign.


