To facilitate NMFS' understanding of the ROC proposed action and to better prepare us for for meeting the consultation timelines, we request the following:

1. A list of analytical tools, methods, and models that are planned for use in the BA effects analysis. We'd also like to know now specifically whether the BA analysis will include use of the CV Temp (i.e., RAFT) temperature model and the temperature-dependent egg mortality model (i.e., the Martin model).
2. Tables identifying the operational criteria and project parameters. We recommend modeling these tables after Tables 3.3-1 and 3.3-2 of the California WaterFix BA. NMFS found these tables to be very useful because they indicate how the model is coded to characterize the desired conditions, which is critical to understanding the proposed operations and effects on the species as analyzed in the BA. Additionally, we are familiar with their format.
