I am attaching my comments on Version 11 of Shasta Effects. Thank you and Evan so much for doing so much work on it. It is greatly improved. Please look through my comments in the morning - - not too many; and see what you can do to clean them up and circulate a clean draft with lots of caveats to Reclamation by

COB today. There are some changes that should be made that ought to be fairly straight forward - - like making sure the ranges of effects of TDD are explained similarly to how we scrubbed them and presented them on the powerpoint presentation. Also the written summary of the rule of thumb chart is inaccurate, Some things like that should be fixed before sharing, then keep working on the rest.

I am clearing this for purposes of Reclamation and peer review; I will want to see another version with my comments embedded and addressed prior to final clearance.

btw - - I did go ahead and hit the "comment resolved" button where my comments were not "greyed out" but were adequately addressed. I hope that's what you want me to do. Give me other instructions if you like - - I am trainable.
