**Brian & Joe (& Jeff)** -- Attached are the final write-ups/tables for the East Side Division (Stanislaus River). Files are saved on the ROCON server as described below.

I'm still tying up loose ends for San Joaquin River "division", but the effects writeups and I&S tables will focus on rearing & outmigrating juveniles for CCV steelhead and CV spring-run and the effects and I&S tables will be essentially the same as for those species/life-stages on the Stanislaus. The green sturgeon writeup for the San Joaquin River "division" will mostly defer to the Delta section for effects to species and CH.

Effects:

Change to DO compliance point ("DO doc"): *2.5 and 2.6 East Side Effects V1\_Stanislaus complete.doc*  
Seasonal operations, SRP, and conservation measures ("SRP doc"): *2.5 and 2.6 East Side Effects V2\_DO Requirement*
