Hey Cathy,

I noticed I had 2 wrong numbers in the last version (v3) which I've fixed and highlighted in yellow in the attached version (v4).

Also I did a thing. I used the metrics to look at how often the modeling showed an exceedence (TDM) or under-performance (ETF). Last page of the attached version (v4) has a table describing this. I think this shows that even if there are frequent instances of high TDM (above a particular metric) the frequency of low ETF (below a metric) is less frequent, meaning a "warning" or "convening a panel" would occur less frequently (acknowledging the modeled ETF is really just a modified TDM value but the ETF metric is different so it's like measuring the TDM 2 times, once with the TDM metric and then with the ETF metric.)
