Removing WOA from the excel file figures is easy. I didn't see this WOA-in-the-figures issue in the daily notes from last week, so maybe we can discuss today. The excel file they provided has a nice dashboard to quickly get to whatever plot you want.

FYI, I did need to change the data labeling to make it clearer. For example, changed COS6 in the excel file plots (see example below) to just Current Operations (not shown in this email). And PA5 to Proposed Action. I scanned the data and it seems the excel file does indeed match the results displayed in the BA (second figure below), although the scaling in the BA is odd - no need to have a scale up to 84 F when the max temp is below 56.





Figure 15-12. American River below Nimbus Dam, March

Maybe. Two things...can we give them a list of figures that we want WOA removed for?


