Hi Garwin,

The Hoopa Valley Tribe and the Yurok Tribe have been asking about the reinitiation on the CVP. Can we send them the MOU and draft schedule? They are wondering how they can engage. Who would be the primary contact from Reclamation that they can reach out to?

The MOU states: Federally Recognized Tribes with a specific interests or concerns regarding the Reinitiation of Consultation on the Coordinated Long-term Operation of the CVP and SWP, will be invited by Reclamation to become a cooperating agency for the associated NEPA process. As a cooperating agency, these Federally Recognized Tribes will participate in the development and review of the EIS and identify issues and provide information to be considered. Moreover, Reclamation leadership will engage in Government-to-Government consultation if requested by the Federally Recognized Tribe(s), seeking their input and considering their interest as a necessary and integral part of the decision-making process.

The NEPA process is ramping up and it doesn't appear Reclamation has reached out to the Tribes yet.
