- Reclamation's modelers are scrambling with the modeling and results, but won't be done in time for tomorrow or next Thursday's workshop to have meaningful results or a presentation put together.
- No formal agenda for tomorrow (that I know of), but we will talk about temperature operations to date in 2017, and an update on the modeling effort.

-- Questions we need to address:

++ Because there likely won't be any presentations or visuals, we're wondering if we should switch the workshop to a conference call, to save folks from driving multiple hours.

++ What next? We should still keep the Thursday afternoon block of time to update folks on the current status of temperature management and update on the system-wide modeling, but because it will just be an update, we should schedule an actual workshop #4 for a later date.
