Stressor Intros: Check with Evan on these. He was going to combine Kate and Stephen's work on references and other things late Friday, but I told him that they could go for review as is (without cite while you write) to save him the weekend and prioritize Shasta work (we'll need him later). I'm sure they are fine as is. The key task will be to clarify for reviewers WHERE in the document they should expect to see them.

Climate Change: This is not formatted in a section yet. I thought we would tack on to effects, but we should discuss. I can get this formatted/situated however you like. This has been dangling and needs to land.

LCM: See here S:\Draft BiOp\2_ESA\2.5-2.6 Effects of the Action\LifeCycleModels. We are awaiting a small additional analysis from Noble. I'll check in with him. But this can go. This is NOT reflected in the I&S.
