Barb/Jeff—Thoughts? I did see what looked like an excerpted example of the figure in the high-level summary of effects PPT presentation that we provided last week.

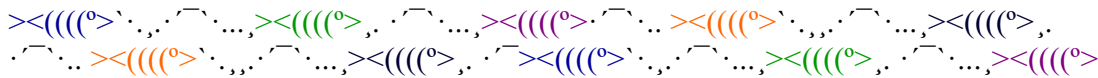
