Garwin --

A few updates:

1. We've generally given people a reprieve for this weekend, given the extension and lack of urgency for peer review deliverables. However, I do plan to send something to the team to see if anyone wants to put in some time on non-urgent things that I can identify that still need to be done.
2. Tables showing stressor, response, risk, and eventually expected change in fitness. **I suggest you decide if these are going in the effects sections or the integration and provide that guidance.** After talking to Susan and Joe and peeking into the East Side and seeing truncated ones there, it seems that it is still not clear. We think it would be easiest for the full tables for all components and effects (i.e., not just the "major" ones) to stay in the integration.
3. All division leads should also look at updated I&S tables in I&S sections and correct, if necessary, the added-back-in rows for beneficial (or formerly uncertain) effects. They should also cross-check their effects analysis text to see that they discuss these actions in the text. See Joe's email below. It's worth it for you to give the directive to do this.
4. We got Susan for the duration!
5. I and Evan are working on performance metrics for Monday afternoon.
