My thinking, which can totally be swayed, is to use the February 5, 2019, BA, but also have citations/references to 2 other Proposed Action (PA) sections: (1) April 30 (or so), 2019, and (2) June 11 (or so), 2019. All 3 are important and necessary:

- there's only 1 BA
- Everyone used the April 30 PA chapter
- were supposed to get a new PA chapter "by COB today," but I don't think it's right to replace all mention of the PA with that. The June 11 version of the PA should only be cited in the new supplemental analyses.

That's a good point. What's the decision, "term-inator"?

FWIW, we can make a placeholder EndNote entry that at least has Author: Reclamation and Year: 2019. That can be inserted into the documents with a dummy title for now. Then once we decide on the version that will be "THE" entry, we can revise the placeholder entry to reflect that, and then have EndNote update the in-text citation to correct the bibliography entry.
