Below are some of the key milestones to track to in the Yolo Bypass over the next several years:

- June 2019 - Wallace Weir Fish Rescue Facility becomes fully operational
- December 2019 - Fremont Weir Adult Fish Passage Modification Project construction complete

- Highlights related specifically to implementation of the Yolo Bypass Salmonid Habitat Restoration and Fish Passage Project:
 - August 2019 - ROD/NOD signed
 - Summer 2020 - Preconstruction vegetation clearing and site preparation begins
 - Summer 2021 - Project construction
 - 2022 - 2027 - Initial operations and calibration period; will depend on real estate acquisitions
 - 2025 - report effectiveness
 - 2028 - report effectiveness
 - 2031 - report effectiveness
- May 2020 - Agricultural Road Crossing 4 project begins construction
- May 2022 - Lisbon Weir Fish Passage project begins construction
