Hi Barb,

For things that I'm familiar with (IEP and RBDD monitoring) I've added take coverage type to your attached list (primarily section 10). I'll defer to you and Sarah on the format of a table, but the vast majority of monitoring take is covered under section 10, and it will probably stay that way for the foreseeable future. With the format of the BO I think most monitoring would fall under a 'framework-level effect' and maybe it should be an appendix rather than included in the ITS section.
