I haven't seen those sections to know details, besides to know that Jeff's is long and he isn't done yet, and that Brian and Joe used the 2009 format/structure. so they may not get to a point. Jeff tends to over-do, so keep that context point in mind.

I took a look at yours just a bit ago and see that you did cover each of the ops for each of the species. I think I did expect to see a bit more as it gets fleshed out to the effect to the species. But again, it's worth it to have more on the effects that we are more concerned about, and do whatever we can to at least minimally address the others, rather than miss them completely, if that's all we can do given the time constraints. Some of that is going to be identified during review because others will help discern which parts need to be beefed up.

At this point, I don't think it will help to stress too much about how yours compares to others. There's plenty more to do, so stick with the plan and stay as consistent as you can in an effort to get it all done. We'll work things in during another pass.

It's becoming clear to me that we'll constantly be updating sections to the end...even my own. This is its state for now, and it will evolve as more people help you figure out how to shape it. You're doing ok!
